2. I understand that Liberty Alliance will refuse to accept or otherwise evaluate any work in the absence of the acceptance by me of each and all of the provisions included of this release form.
3. I represent and warrant that I am the true author of the work submitted and that I have the exclusive and unconditional right and authority to submit said work to Liberty Alliance for publication. I warrant that any and all accompanying photos, artwork, or other images were produced personally or obtained from a photo supplier legally and in no way infringe upon the copyright of any third party (eg. Shutterstock.com). I hereby indemnify and save Liberty Alliance harmless from any and all claims, expenses, losses, or liabilities that may be asserted against or incurred by Liberty Alliance at any time in connection with the said work and/or any image utilized in conjunction with its publication. I acknowledge that I am solely responsible to ensure the work and accompanying image(s) are free of any copyright.
